Research Updates

Laura Pinheiro, PhD, Assistant Professor of Health Services Research in Medicine, and Co-PI Shoshana Rosenberg, MD, from Weill Cornell Population Health were awarded \$150,000 from Pfizer and Conquer Cancer for their project entitled *Identifying Unmet Needs and Barriers to Receipt of Psychosocial Care in Men and Women with Metastatic Breast Cancer from Diverse Racial and Ethnic Backgrounds Treated in an Urban Hospital Network.*

Laura Gingras, MD, Assistant Professor of Clinical Medicine, has been awarded the NewYork-Presbyterian Dalio Center for Health Justice 2022-2023 grant in the amount of \$100,000 for her project on *The Patient Activated Learning System (PALS) to Improve CVD Disparities*.

Christopher Gonzalez, MD, Assistant Professor of Medicine, has been selected as a recipient of the 2022 Pilot Grant Award of the Mastercard Diversity-Mentorship Collaborative at Weill Cornell Medicine in the amount of \$50,000 for his project on *Developing Weight Management Interventions for Hispanic Immigrant Men in Under-Resourced Settings*.

Primary Care Innovations (PCI) Program

On February 24, 2022, the PCI program hosted the 5th
Annual Primary Care & Hospital Medicine Innovations
Symposium virtually with a large national attendance
during #ProudtobeGIM week. This year the PCI program
provided \$82,000 to fund 5 innovative interdisciplinary
projects across campus, consisting of 3 faculty, 1
resident, and 1 student awardees in various topics

Dean Augustine Choi, and Dr. Judy Tung. A keynote
address was given by Aswin Vasin, MD, 44th
Commissioner of the New York City Department of
Health & Mental Hygiene, on Public Health and





Healthcare in the (Post) COVID-19 Era in NYC: Opportunities, Challenges, and the Road Ahead. Followed by an informative session from Drs. Christopher Gonzalez, Tanveer-E-Fatema R. Hassam, and **Zachary Mulvihill** on *Leveraging Fellowships for* Careers in GIM. Other event highlights included past competitive seed grant presentations, top abstract presentations, and compelling poster sessions from abstracts selected during an open call for abstracts earlier this year. This year's event showcased posters from medical students, residents, fellows, and faculty from WCM, NYP, Global Health, Cornell Tech, Population Health Sciences, and Cornell University. The event concluded with closing remarks and a Twitter raffle giveaway from Dr. Monika Safford. The symposium was a forum to get to know others with similar interests and to become familiar with the ongoing innovative work on-campus and off-campus in the Primary Care arena.

The Cornell Center for Health Equity has made great strides towards one of its missions to generate and share new knowledge, through its pledge towards research development by offering funding opportunities and grant writing development training. The Center has committed to funding two grant cycles this year, focused on community partnership building and generating pilot data.

The community partnership building grants, committed to supporting projects that aim to establish or strengthen collaborative partnerships have been awarded to two Cornell University Principal Investigators: Rana Zadeh, PhD, Associate Professor, for the project entitled Home Opioid Prescription Education and Smart Storage (HOPES) Program in Tompkins and

Cortland Counties: Design Meets Medicine to Improve Health and Independence for Older Adults with Dementia at Home and Karla Hanson, PhD, for the project entitled Collaboration among Health Care, Visiting Nurse, and Meal Delivery Services to Support Population Health and Position the Team to Conduct Implementation Research in Rural Areas. Both projects were awarded \$5,000 each.

Last month, the Center announced a new request for proposals for one-year grant support for research or scholarship. The primary goal of this opportunity is to support impactful projects ranging from \$15,000 to \$50,000. **The application deadline is April 15, 2022**. applicants. This year's program was virtual and had over 100 participants and participation from program leadership and faculty from Weill Cornell Medicine Internal Medicine, and eight additional departments.

The path to medical school is a difficult one but a well worth path. We are thankful for the faculty that have helped us grow the network of pre-medical students affiliated with the Pre-Medical Diversity Initiatives.

The Diversity Center of Excellence hosted its third annual Health Equity pre-medical conference on Saturday, March 12, 2022, for 70 students interested in health equity. This year's conference theme was "Building a Workforce for Health Equity and Health Justice." We kicked off with opening remarks from PI/Director Dr. Susana Morales and faculty lead Dr. Andrea Card. In addition to a keynote address, participants had a session on admissions, financial aid, and a panel discussion with current Weill Cornell Medical students.

Dr. Andrea Card, faculty lead for the Pre-Medical Diversity Initiatives, launched the second cohort of the Careers in Medicine Enhancement Program (CMEP) with 26 talented pre-medical students selected from various linkage schools affiliated with the Pre-Medical Diversity Initiatives, CMEP is an 8-week academic enrichment program opportunity offered to undergraduate and recent graduates from City College, Columbia, Cornell, Fordham University, Hunter College, and St. John's University. Moreover, Dr. Andrea Card hosted the Diversity Center of Excellence presentation night for the second cohort of Careers in Medicine Enhancement **Program** (CMEP) on March 23, 2022. During the evening, 21 presentations were given by undergraduate and gap-year students with topics on the U.S. maternal mortality rate, health disparities post-Hurricane Katrina, and mental health disparities in the prison system.

The Diversity Center of Excellence is preparing for the spring semester of **Dialogues in Health** sessions. Virtual

Appointments & Promotions

Sanjai Sinha, MD, has been promoted to Associate Professor of Clinical Medicine on February 1, 2022. Dr. Sinha has expanded his work to include video visits and telemedicine to assist with the hospital-to-home transition. When the COVID pandemic disrupted his work, he pivoted from video visits for post-



discharge care to COVID care. In addition, he is also a co-investigator on efforts to improve the quality of race and ethnicity data in our electronic medical record, and outreach efforts to improve breast cancer screening rates among minority women. He is actively involved in the development of the Patient Activated Learning System, and holds a leadership position as Senior Director of Content Development. He has published over 100 evidence summaries that are viewed internationally by tens of thousands of patients. We are extremely excited about his accomplishments and promotion.

Laura Pinheiro, PhD, Assistant Professor of Health Services Research in Medicine, has been appointed to Associate Director of Curriculum for GIM Fellowship Programs. In this leadership role, she will meet individually with each research fellow to design an individualized training plan for

Given Dr. Pinheiro's study design and statistical expertise, she is very familiar with short-term and semester-long courses and workshops taught across the country. weekly with Drs. Safford, Shapiro, McNairy, and Morales to discuss recruitment of future fellows, progress of current fellows, mentoring teams, and additional training and development opportunities.
