

## **Instructor in Medicine or Assistant Professor of Medicine/Section of Hospital Medicine/Division of General Internal Medicine**

### **Academic Position Summary:**

- The Division of General Internal Medicine, Section of Hospital Medicine in the Weill Department of Medicine at NewYork-Presbyterian/Weill Cornell Medical Center, is seeking academic board certified/board eligible general internists interested in outpatient primary care to join our distinguished faculty. The division of General Internal Medicine is nationally recognized for providing advanced clinical care, conducting pioneering research, offering unique teaching opportunities, and demonstrating commitment to improve the health status of the community we serve. Clinician educators are sought at all career levels; we offer protected time to pursue academic interests in teaching, policy, advocacy and research for highly qualified candidates.
- Weill Cornell Medicine (WCM) is the medical school of Cornell University. Faculty members have clinical appointments at NewYork-Presbyterian Hospital, one of the largest and most comprehensive academic medical centers in the nation and one of New York City's top-ranked hospitals.

### **Academic Responsibilities:**

- This position includes 100% effort devoted to clinical cares to hospitalized patients at Weill Cornell Medicine as well as NewYork-Presbyterian/Lower Manhattan Hospital, consisting of 13 seven-day weeks of day clinical service and 65 nights of nights clinical service). The position is expected to serve as back up for the equivalent of 3 weeks, with additional expectation to meet clinical productivity including submission of professional fees for all billable patient encounters with 27 hours of the date of service.
- This position also includes teaching and academic development, which includes attendance at appropriate conferences, meetings and service committees of Weill Cornell Medical College, the Weill Department of Medicine, and NewYork Presbyterian/Weill Cornell Medical Center, to teach as required, to train fellows, residents and students.

### **Medical Education Requirements:**

- Candidates must maintain an M.D or comparable foreign medical degree
- 3 to 7 years of internship and clinical residency training, specializing in internal medicine
- Certification by the American Board of Internal Medicine (ABIM) in internal medicine
- A valid and active medical license in the state of New York

### **Academic Appointment Requirements:**

- Academic rank of Instructor in Medicine typically includes 1-3 years of academic experience; Assistant Professor of Medicine typically includes 4-6 year of academic experience with first author scholarship related to the clinical field and teaching experience.
- Candidates must have evidence of a strong, local reputation in the clinical field of

Internal Medicine, with a leadership and/or a key role in activities that include practice, such as approaches to diagnosis; treatment or prevention of disease (such as hypertension, heart disease or diabetes, including providing health and wellness advice to patients on diet, physical activity and disease prevention); and in applications of technology to clinical care and/or development of local adoption of innovates models of care delivery.

**Clinical Appointment Requirements:**

- Appointment as an Assistant Attending Physician of NewYork-Presbyterian Hospital contingent upon approval of the Weill Cornell Medicine academic appointment; hospital attending and/or consultation privileges will be limited to Weill Cornell Medicine and NewYork-Presbyterian-Lower Manhattan Hospital, unless otherwise specifically agreed to in writing by the dean of Weill Cornell Medical College.

**Professional Licenses and Certifications:**

- A valid New York State medical license, DEA license, board certification, and all applicable certification and/or credentialing specific to the medical specialty; must meet the qualifications to enroll and participate in all third-party payer insurance plan credentialing.

**Competencies:**

- Must remain compliant with all NewYork Presbyterian/Weill Cornell Medical Center initiatives, including completion of the Weill Cornell Medicine academic annual self-assessment and completion of NewYork Presbyterian's annual ongoing professional peer evaluation.

**Compensation and Benefits:**

- We offer highly competitive and excellent benefits, including 403B, CME, malpractice including tail coverage, LTD and life insurance, and tuition reimbursement for qualified employees and dependents.
