Complex and High-Risk Interventional Procedures (CHIP) Fellowship

The Complex and High-Risk Interventional Procedures (CHIP) fellowship at New York Presbyterian/Weill Cornell Medical Center is a one-year, non-ACGME-accredited fellowship designed to provide advanced training in percutaneous coronary intervention (PCI) strategies for patients with complex lesion subsets including chronic total occlusion (CTO) as well as associated comorbidities and/or hemodynamic instability. This advanced fellowship will hold an academic rank of Instructor in Medicine.

Fellowship Curriculum:

- 1. CTO intervention encompassing all advanced crossing strategies
- 2. High-level integration of non-invasive imaging modalities for patient selection (cardiac PET and MRI) and procedural planning (coronary CT angiography)
- 3. Comprehensive application of intravascular imaging and physiology for PCI optimization
- 4. Mechanical circulatory support for high-risk PCI and management of cardiogenic shock including participation in the shock team
- 5. Complications prevention and management
- 6. Radiation safety and contrast dose management
- 7. Participation in weekly outpatient Complex Coronary Clinic
- 8. Research projects related to management of patients with refractory angina.

Following completion of the CHIP fellowship, trainees will have the necessary skills to become independent operators in complex, high-risk and CTO PCI.
