# Peer Coaching Can Help Marginalized Individuals Lower Blood Pressure



For younger Black patients living in rural parts of the Southeastern U.S., peer coaching is more effective than traditional clinical care in controlling high blood pressure, according to a new study led by **Dr. Monika Safford,** the John J. Kuiper Professor of Medicine and chief of the Division of General Internal Medicine. The <u>findings</u>, which were published in *JAMA Internal Medicine*, found that for people under age 60 who have persistently uncontrolled hypertension, the benefits of working with a peer health coach were equivalent to what would be expected from taking a low dose of blood pressure medication. **Read More**

# Vignettes



**Vignettes** is a historic retrospective highlighting prominent physicians and topics connected to the Weill Department of Medicine. In recognition of March's recent Women's History Month, we are proud to feature pioneer Dr. Connie Myers Guion.

#### Helping Transform Outpatient Care

After graduating first in her class from Cornell University Medical College in 1917, **Dr. Connie Myers Guion** spent more than half a century at New York Hospital- Cornell Medical Center. During her internship at Bellevue Hospital,

she pushed back against the 24-hour ambulance duty required of interns at the time. When she was told the practice had been in place for 100 years, she reportedly declared "Well, the century's up!" The shift was soon reduced to 12 hours.

In 1929, she became chief of the General Medical Clinic at the Cornell Pay Clinic, which helped transform outpatient care for the working class by offering fixed-fee treatments and excellent diagnostic services. Dr. Guion rose to attending physician in 1943 and in 1946 became one of the first women in the U.S. to be appointed a professor in clinical medicine. Dr. Guion also became the first woman to be a member of the New York Hospital Medical Board and an honorary governor of the Society of the New York Hospital. The new outpatient building was dedicated to her in 1963, as the first building to be named after a living woman physician.
